## Shared Housing: Where is it?

- There is a wide diversity of shared housing options and each have their own entry points and specializations. There is no one platform that's one size fits all.
- Associated Ministries hosts two home share programs that provide unique lowcost housing options within private homes. Below are links to learn more about each program.

  - Youth host home program: https://associatedministries.org/supportiveservices/youth-host-homes/
- Case managers have relationships with landlords to get rapid rehousing—even with relationships, it's difficult to find something that's really affordable.
- Peace Lutheran Church—through a partnership with national church, they have four houses that they own and can offer to people in Hilltop under threat of displacement.
- There are opportunities for local churches to partner with national denominations to fund these kinds of needs.
- Black congregations in the community sometimes have housing opportunities.
- Tacoma Ministerial Alliance has developed a bit of housing.
- Fife has the Chateau Rainier complex. BIMA (Believing In Myself Again) is another great program.
- Tacomaprobono has wonderful up to date resource for what is currently available at http://tacomaprobono.org/hjplinks/ Recommended use of Coalition web page as new resources get posted.

- The Hive Home model can provide sub-30% AMI housing, but only for program support, not as stand-alone housing. Legal costs, and provisions in both the Tacoma 4 All and City tenant's rights referendums make low-margin housing unviable.
- Workforce has paths for those who qualify for Career Team, which offers various sorts of training but also sometimes first and last months' rent.
- There are also places like Quixote Village https://affordablehousingonline.com/housingsearch/Washington/Olympia/Quixote-Village/10107001
- Sometimes there can be shared space in unusual settings, such as businesses.
- There are short term rentals such as AirBNB probably market rate.

## Also Duly Noted

- We should have a presentation that highlights the diversity of shared housing options.
- Spoke about importance of small guaranteed annual income projects and rental assistance programs that make it more possible for people with very low income to stay in housing and get a place when need it.
- Reinforced the importance of education in general to help people prepare for housing challenges.
- The answer to all of this is social housing government owned, available at every level of income, rent-controlled. Vienna is a model of this.
- Community buy-in is vital to create successful, public housing. It's difficult to secure buy-in to introduce this from community members who are affluent.
- Housing projects turn into ghettos when there is insufficient investment into the community in terms of support.
- Why are we spending public funds on sweeps and not on publicly-owned housing? Even if it were just a unit in an apartment complex at a time?
- There are way too many regulations to develop affordable housing.
- There should be training to reduce the runaround that people must go through.
- Coordinated entry should be mobile—go to the people in need.
- There is a lack off reciprocity for housing referral options available to and from smaller communities.
