Comments Summary

- Several outreach workers said people they are coming across are much more sickly and weak, due to the increased isolation and stress of sweeps.
- The Tacoma Camping Ban is city-sponsored cruelty,
- People will take more drugs with more harm done by the people that pretend to help them (heal) then will not work with those of us that can help and want to.
- We were in an encampment 2 weeks ago and there were only 3 people. One man came out to us and stated they all ran as they were afraid of us. Once they learned who we were they ran back down into the woods and about 20-25 people came out and engaged with us. Lots of fear out there in the woods.
- The ongoing harm of sweeps is discussed here with dismal regularity.

- I'm glad you are here trying to bridge differences and a difficult conversation
- Always good to reach out to people who are still not aware unfortunately those are the people LEAST likely to show up for such an event. Is there some way to bring this out (to engage) rather than trying to get people who are not interested to engage?
- Creating status-based offenses creates status based criminals
- Mayor Woodards, I would recommend the excellent book Homelessness is a Housing Problem as well. https://homelessnesshousingproblem.com/
- RE: criminalization of homelessness No arrests or fines have resulted from Tacoma's camping ban because the "ban" is not actually enforced. Thus the myth of 100% compliance.
- If the City wants to not arrest people, then continually harassing them and taking their possessions is just a cruel alternative.
- The City does not have the money to solve this by itself. People who will vote to not raise taxes are voting to keep rates of homelessness high. There is not enough subsidized housing for the 0-30%, which is a primary cause of homelessness.
- Homeless enforcement is best handled with HOUSING. Meaning, MORE affordable housing. Heck, probably half of the U.S. population needs a rental subsidy.
- The people I take water to are not mobile enough to run away so they lose their possessions over and over and over. Often taken by contactors hired by the City to "clean up." It's appalling.
- The invisible unhoused population (individuals with full time jobs, but do not appear to be experiencing homelessness) is growing.
- Does mayor woodwards want to respond to the report we heard earlier about police following the needle exchange to enforce sweeps?
- How do we face our abuseres when it is the officials out to help us?
- From Manni Valenzuela, previous Rapid Rehousing case manager with multiple agencies in Tacoma, and current Park Guide with Metro Parks Tacoma. I have to agree with Rob and with Rosemary regarding the negative impact the sweeps have on our access to support and reach folks as well as extreme damage to community trust.
- Remember that the camping ban just barely passed in the Tacoma City Council there are a number of council members who opposed the ban. There may be room for reversing the ban after seeing the impacts of the ban IF there is an honest appraisal of that impact. Thank yo Mayor Woodard for entering into this space and being vulnerable yourself.
- The sweeps have left us somewhat demoralized. Is much more difficult to connect with and provide the supplies people need. Outreach is less effective.
 Relationships more difficult to maintain.
- Jay and Courtney, your continued advocacy is so important. We know it comes at a significant cost to you.

Calls to Action

- This conversation is needed AND the city lacks the credibility to host this conversation, at this point.
- The money you put into moving and harming this community can go to social housing and fix this
- Mayor, I invite you to join our outreach teams as we talk with folks who are being beaten and shot by NIMBYs targeting tents.
- The remedy: rational policies instead of wishful thinking and a TRUELY unified regional approach that is guided by the needs of the community - particularly people with lived experience
- The jurisdictions who make up the possible "unified regional approach" could start by telling the City of Tacoma to stop the Sweeps, in a unified message that Sweeps are counterproductive to the goals of the Plan to End Homelessness..
- We need to go to open comment at city council en masse, write letters and call our repersentitives. We must get loud.
- CM Gunther here, Ms Woodards. Attended your AWC speech this summer. What is needed is homeless cultural competency training for us politicians. During Council meetings I rarely hear about the unhomed's heroes and accomplishments -- only their deficiencies. This 1960's mindset creates skewed decisions like it has for other minority groups through history. The homeless deserve equal treatment by cities under God and the law.
- Ms. Woodards, please talk about our heroes at Council meetings. Change the narrative. Dr. King said much about this area. People look up to us. We are not a bunch of drugs and needles and trash. Politicans need to do better, instead of taking pages out of 1960's playbooks.
- Thank you Mayor for coming onto to the call. It iss evident we need more discussions and you including us as a voice for the community of unhoused individuals. Thank you!
