Problems with Sweeps

- Sweeps not promoting public health, both from a law enforcement community perspective and impact on houseless.
- Camping bans being a human rights violation. City of Tacoma forcing people to sleep on the streets due to lack of shelter, but also punishing people for sleeping on the streets.

Contributing Issues

- People in charge at the city don't really have a clear picture of homelessness in the city.
- It should be unbearable for us to know that the substantial suffering that's going on out there is only increasing.
- Council members have different ideas based on their districts. They should visit other council districts.
- Council members don't come into this space, so how can they hear us?
- Often most vulnerable people not being entered into shelter due to being "too vulnerable."
- "Not In My Backyard" attitudes limiting access to affordable housing.
- Issues with City of Tacoma and churches.
- This is a countywide issue.

Potential Solutions or Actions

- Props to the Mayor for being brave enough to come to us.
- Props to Jay for being bold and strong.
- Make firm demands of action from the city before more talks.

- We need to rise up as grassroots citizens.
- Sweeps were supposed to increase shelter capacity.
- Look at who is invited to speak at study sessions ei therapeutic courts.
- How does Lived Experience and PC Homeless, etc, get invited to speak at study sessions?
- Get public officials to come to meetings and hear about what's happening in the city.
- Use of churches to provide RV hookups or bathrooms to support the needs of people coming to camp.
- Safe Parking with churches placed under shelter codes.
- Questions around private businesses providing "safe" places to shelter.
- We should work together to vote some of our council members out.
- We need publicly funded elections and RCV (rank choice voting) to effectively change who our elected are or can be.
- Need to lean into our common humanity during these discussions and make our experiences meaningful to each other.
- We need genuine community dialogue that reassesses the impact of the sweeps strategy. We should shoot for a community dialogue event in November that brings people with different perspectives together to discuss reducing the harm of unsheltered homelessness. This leads into a discussion of the need to stop the sweeps in a way that people can hear.
- Int'l homeless day is Oct 10 and Oct 12 is anniversary of sweeps legislation, which points to an event then. There is energy for working on this.
- Common Good Tacoma is working on a "listening event" for Sept. 28 at 1st United Methodist that invites the Mayor and Council to hear lived experience perspectives.
