Priorities to Address

- Read Homelessness Is a Housing Problem!
- Coordinate and collaborate on true data and transparency.
- Accurate daily shelter availability reporting.
- How do the city and county work together to increase resources?
- Need more leadership on grant support from County (King and Sno doing much better).
- Improve the barriers to shelter access by folk w disabilities.
- Need 24/7 coordination for weather response.
- Centralized resource centers that are 24/7.
- Stop the sweeps! Fund permanent supportive housing! Fund outreach!
- Trust building is not just between the councils, also with the community & providers.
- Increase proactive approaches that are about prevention: infrastructure, rent caps, min wage.

- Address structural issues like low-income housing and living wage employment opportunity.
- Policy piece is there low-income housing being built (yes/no group had different opinions about income eligibility).
- Need to fund homeless prevention.
- A lot of prevention funded during pandemic going away, such as landlord tenant services.
- Make it legal to live in vehicle homes.
- More spaces for safe parking and camping.
- Understanding of what the camping ban is and is not accomplishing.
- If we cannot actually provide shelter, we need to provide things that make immediate, material improvements in unhoused people's lives hot food, hygiene, laundry resources.
- Each municipality could offer a minimum of 1% of its population worth of shelter.
- Programs receiving public funds should provide metrics: quality and impact measure.
- Data needs to be correct, and disaggregated by geography, demographics, etc. and capacity for funding for data capacity should come from sources different than those designated for housing, services, etc.
- Pool resources with a centralized resource closet to streamline getting items out to people.
- Importance of hiring leadership/staff outside of the county who can build trust and bring equity expertise.
- Importance of shelter/place specifically for people who want to get clean while waiting for admission to treatment.
- Coordinated entry needs a serious overhaul; need responses that are both standardized and adaptive to individual circumstances.
- Importance of services being co-located (e.g., community center models, triage, not everyone can network).
- Move ahead with the URA as described, with MOU -> ILA model. "Move quickly."
- As part of the URA, create advisory committees focused on this issue and include those
 with lived experience. Need to dispel myths for council members and include the voice
 of those with experience.
- Build another large encampment like the one at 35th/Pacific, that is sustainable, affordable, and self-managed.
- Note that programs need to include significant follow-up for people in recovery.
 Important for policy-makers to know that treatment alone is not enough, and money is needed for additional support following treatment.
- Five things: leadership, call to action, break down the damned silos, communicate with the public and develop affordable housing.
- City and County are not building equity for the future. need to better coordinate on better use of land and other public resources.

- When we sell off our public property it is lost forever the "opportunity costs" of shrinking public (social/workforce/whatever you want to call it) housing don't seem to be considered and they should be.
- Unhoused people are a We issue rather than a Them issue; a reflection of system failure we all have a responsibility for.
- Need city and county on same page pulling in same direction.

Possible Coalition Action Items

- Need specific asks to be effective.
- Need to hold City and County accountable; coming to the table isn't enough.
- It would be helpful to have regular representation at those joint meetings and can report back to the Coalition such as Rob
- Have to educate about rural homelessness recognize that unhoused people are everywhere
- Repeal camping ban (county could be pressure point).
