Thoughts on the SCOTUS matter

- Jennifer Ammon's summary of Martin v Boise and Johnson v Grants Pass and the SCOTUS decision was outstanding. We await further news.
- Connect city manager decisions re: ADU's and criminalization of homelessness she contributes to the problem and blocks solutions.
- The Amicus Brief theme is that cities don't want to serve ALL their citizens. The ones that are unhoused they would rather harass in an effort to drive them off instead of address the problem.
- How can the City Attorney sign on to a brief without consulting the council or public? Surmise City Manager directed City Attorney.
- Recommended national strategy of not raising legal profile of case applies to the action before the court, not discussion with city official or limits to local response.
- Sweeps doing great harm, making things worse, cutting off relationships with homeless folks because they keep moving and we can't find them.
- Congregate shelter is not the answer but it seems to be what the City wants to force people into.
- Sweeps as a response to homelessness is akin to a child pushing their peas around on their plate to avoid eating them. It's not a solution. It is wasted effort to make an unpleasant task more unpleasant.



- Rally the crowd to be riled about lack of transparency after SCOTUS decides not/to take the case.
- The case was scheduled for discussion/decision on 10/27. Now that SCOTUS has requested a response by 11/6/23, we'll likely know if they will rule in early December.

A short list of things better than sweeps:

- For a person to actually make progress, it takes a lot of other people stepping up to help them tangibly.
- Why aren't the unhoused people with disabilities clients of the County Aging and Disabilities Services?
- Why aren't we looking at specialized housing like mental health group homes, adult family homes, clean and sober houses, recovery housing, assisting living

model type housing, etc.? These are HOUSING options with special elements for people with various challenges.

Other far-ranging conversations ...

- Engaging in creative visual politics is an essential means of conveying our message.
- **City charter review comes up in 2024.** Tacoma's current model is typical of cities with less than 50,000 residents. Some improvements could be:
 - Make council positions full time. Currently they are part-time jobs only accessible to persons with rich spouses. The work expectation is closer to 60 hours/weeks.
 - Provide staff for council members to gain institutional expertise and increase capacity for investigation/follow up
 - Reduce City Manager role to City Administrator. Administrator is focused on support and has less autonomy.
