What was the least wonderful housing situation you have lived in, and what were your alternatives at the time? Group Discussion Summary • Tacoma Pierce County Coalition to End Homelessness • 10.20.23

"We are a quilt of approaches and methods to end homelessness. We need to move from 'intractable,' to 'We can do this together.'" — Sally Perkins

Remembering the bad housing we needed at the time ...

- Couch hopping due to DV situation. Had to keep moving as perpetrator found location.
- Lived in a tiny room in Taiwan sometimes had to forego eating for rent, but still
 relatively luxurious. Option would have been a school dormitory with about 6
 other people.
- Lived in a co-op with about 16 others with shared bathroom and kitchen, but own room with a closing/locking door. Other option would have been a similar, shared housing option or moving in with family.
- Tents in a warzone, improvement was CHU: Contained Housing Unit. Can make 3 units out of a large trailer. Possibly buy surplus off Port or military?
- Lived in houses that were badly partitioned into rental units with shared bathrooms and hot plates and such for cooking.
- Cheap shared collective student housing ("We had an organic garden in the backyard so, how bad could it be.")
- Talked about vulnerabilities of sharing housing with relatives, etc.
- "Even the hippy version of homelessness, out in the country in a trailer with no electricity and water, was still devastating. The trauma of being unsheltered stays with you."
- One of the individuals in our group was separated from their father when they
 were 6 in a shelter, as they were not permitted to stay in the men's shelter. Lack
 of consideration for the growing number of dual male or single male households
 with children.

Issues and Solutions, not necessarily in that order

- Frustration with conditions of people who are even in shelter settings.
- Frustrated with the general situation and lack of empathy. The majority of folks are apathetic about homelessness. There seems to be no real impetus to make systemic changes.
- Need alternative = different shelter model that truly accommodates families.
 Discussed factors impacting choice as to what housing is preferred. For some (those with TBI, PTSD, and other conditions, living in a tent car is preferred over sharing space with another person. Some people also have issues surrounding shared bathroom/shower issues.

- On a related point, looking at the design of temporary shelters using truck trailers, and repurposing other structures.
- The potential of using dorms on campuses incentivizes universities to offer their campus housing, UPS, PLU, UWT.
- Shared spaces are challenging. Kitchens, laundry, & showers are points of conflict.
 Many folks choose more space unsheltered or less sheltered over shared housing or congregate shelter out of fear of conflict & feeling vulnerable.
