Notes to City Government ...

- Electeds might feel helpless and overwhelmed.
- It doesn't look good to the city to see families on the street.
- When designing policies, cities have responsibility to not treat shelter as a commodity and to see unhoused people as human beings, worthy of dignity and respect.
- City has responsibility to not create gratuitous harm and for knowing the cause of problems and to at least plan to address them.
- We as a city are responsible to ensure that people don't die of poverty. This means a minimum level of shelter, nourishment and capacity to deal with toileting, sleeping and sitting down.
- Perhaps if we set a standard that people have the same rights given to cats and dogs, we could see improvement of prospects for our most vulnerable citizens.
- City seems to be approaching this in an adversarial way in terms of relationship to Coalition.
- Until attitudes and mindsets change, we'll continue in this dysfunctional cycle.
- The city doesn't seem to acknowledge that we're all in a dialog to improve the situation and build solutions. Too often hostile or even dismissive.
- "The dismissiveness is like fighting with Jello."
- Change probably needs to come through the Coalition. We could go further if we could work together.

• The government seems to focus on Safety and Security Needs (Maslow's 2nd tier), but is denying access to the prerequisite Physiological Needs.

If: We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America

Then: We have a responsibility care for, protect, and provide opportunity for ALL people, not just those able to 'bootstrap' and pay for their own care.
